Included in this document are six pre-made address labels for the 2017 ENnies season. Before shipping, please read the following:

1. Products submitted must be samples of those primarily available to the general public.
2. Software must be provided ready to install with full activation and codes.
3. The ENnies require six copies of each title: one for each judge and one (a.k.a. the "6th Copy") which is used as reference material during the judging period, for display purposes at Gen Con Indy, and possibly for fundraising purposes.
4. Contacting judges to discuss your submissions is strictly forbidden. If you have questions or concerns, contact the Submissions Coordinator at [entries@ennieawards.com](mailto:entries@ennieawards.com).
5. Judge's phone numbers for shipping purposes only are available upon request.
6. **Please be certain to include the entire shipping label and/or to include text on customs forms declaring that the shipment is for promotional/evaluation purposes only, not for resale, declared (for customs) value \$1. Failure to do this may result in your product not being delivered in a timely fashion.**
